5. Underdevelopment and underdevelopment of African languages. Writers cannot write in languages that have not been developed to have a written form, or languages that have not been developed to the level at which language is the only way to reach every individual in the society. Oppose him by using six points.

Absence of government language policies. Government policies that could encourage the use of African languages in African literature are absent.

Lack of promotion of African languages in Employment and Education system. There is no African country where a credit pass in an African language is a criterion for promotion in the civil service, admission to a university or employment.

Complex linguistic situation in Africa (Multilingualism). It is estimated that there are 2035 African languages at present. This situation is possibly responsible for the lack of government policies that could encourage the use of African languages in literature.

The cost of developing African languages. To develop a language is capital intensive. It is therefore difficult to develop all the languages of Africa to be used in literature.

Lack of commercial value (market) for literary works written in African Languages. Commercial value of novels, plays and poetry books written in African languages is infinitesimal (extremely small) compared to such works written in English or French.

Lack of literacy in the African languages. In other words it is hard to put most African languages in written form. This is a major factor that affects the commercial value of the literary works written in the languages.

The problem of publication. Most publishers are not willing to publish works written in African Languages. Publishing of literary works in African languages is a biggest challenge

In literary works, language is the medium or vehicle through which the message to the readers is transmitted. Therefore, in molding their works, literary artists choose the language appropriately in order to effectively convey the intended message to their readers. This explanation WILL BE exemplified by the writers of the novels "HOUSEBOY" and A WALK IN THE NIGHT who are F. Oyono and A. Guma. respectively.

MAIN BODY (CONTENT)

In this part, the candidates is required to identify the elements of language use that each writer has employed in order to effectively convey/deliver the intended message to the readers.

The use of offensive language (obscenities)Eg. Toundi says "A great chief like the Commandant uncircumcised.

The use of figures of speech.The writer has used different figures of speech such as symbolism, imagery, simile, metaphor in order to convey messages to the readers The use of sayings,inorder to convey messaged to the readers.

In the novella "A WALK IN THE NIGHT". The writer has used the following language elements in

(i)The use of non-standing English

The writer has used non-standard English to reveal the lack of education and low living conditions among the Africans, because poor and non-educated people tend to use non English. There are words like. "howzit" (p. 3)

(ii) The use of abusive language.

The writer has used abusive language to show the African's resentment towards the whole situation of racial injustice, but also to portray the picture of moral decay because such language is also used by the whites like constable Raalt. For example "hoit pally (p. 3)

"You bastards, you want to get shot too" (p. 84)

"That son of bitch, that bloody sonovabich" (p. 5)

(iii) The uses of figures of speech.

The writer has used different figures of speech like similes, metaphors, personification, symbolism and hyperbole. For example, in page 18, the writer has used the symbol "goose" to mean a woman. The symbol has been used to show the society's disrespect towards women.
